Release Forms

Obtaining proper written permissions is the responsibility of the producer and can prevent complicated problems down the line in the event you license the broadcast or distribution rights of your video.

The four most common release forms used in video and documentary productions are:

Appearance Release

for non-actors

Minor Appearance Release

for children, it must be signed by a parent or legal guardian

Materials Release

for obtaining permission from the owner or license holder to use photographs, audio, video, video or other media which may be copyrighted or owned by others

Location Release

for use when you are videoing on property you do not own

If you're working with professional actors and personalities, you'll probably need a special actor/model release form. Or they may give you a release form.

For locations, it's important to know who actually owns the building or land you want to video on and also to find out who the current occupier is. For example, if you are videoing in a rented house you should get permission from the landlord as well as the tenant who is renting the property.
